Board Review and Consideration that as a result of the COVID-19 emergency: (i) meeting in person would present imminent risks to the health or safety of attendees; and (ii) the meeting is authorized to be held by teleconference pursuant to Gov. Code, § 54953, subd. (e)(1)(C).

Background:

Consider finding by a majority vote under Gov. Code § 54953, subd. (e)(1)(B) that as a result of the COVID-19 emergency: (i) meeting in person would present imminent risks to the health or safety of attendees; and (ii) the meeting is authorized to be held by teleconference pursuant to Gov. Code, § 54953, subd. (e)(1)(C).

In light of the Governor's declaration that a state of emergency exists due to the incidence and spread of the novel coronavirus, and the pandemic caused by the resulting disease COVID-19, the board should consider whether meeting in person would present imminent risks to the health or safety of meeting attendees.

The Centers for Disease Control indicates that COVID-19 is a highly transmissible virus that is spread when an infected person breathes out droplets and very small particles that contain the virus, and such droplets and particles are breathed in by other people. Since June of 2021, a more infectious variant of the virus, known as the Delta Variant, has emerged and now accounts for the vast majority of COVID-19 cases.

Although effective vaccines have been approved by the U.S. Food and Drug Administration for emergency use, vaccination rates are slow and have not yet reached a point to significantly control community transmission. As of August 11, 2022, only 71.8% of Californians who are eligible to be vaccinated are fully vaccinated. ²

Those who become infected with COVID-19 are at risk of serious illness and death. **As of August 11, 1,035,678 Americans have died from the virus**.³ Many more have been hospitalized with serious illness. In Placer County, the COVID-19 Community Level is "High" with a case rate with new COVID-19 admissions 13.5 per 100,000 population.

Conducting meetings by teleconference would directly reduce the risk of transmission among meeting attendees, including members of the public and agency staff, which has the ancillary effect of reducing risk of serious illness and death as well as reducing community spread of the virus.

If the authorization to meet by teleconference is not approved by a majority vote, then the meeting will adjourn after this item and the remaining agenda items will be rescheduled to a future in-person meeting.

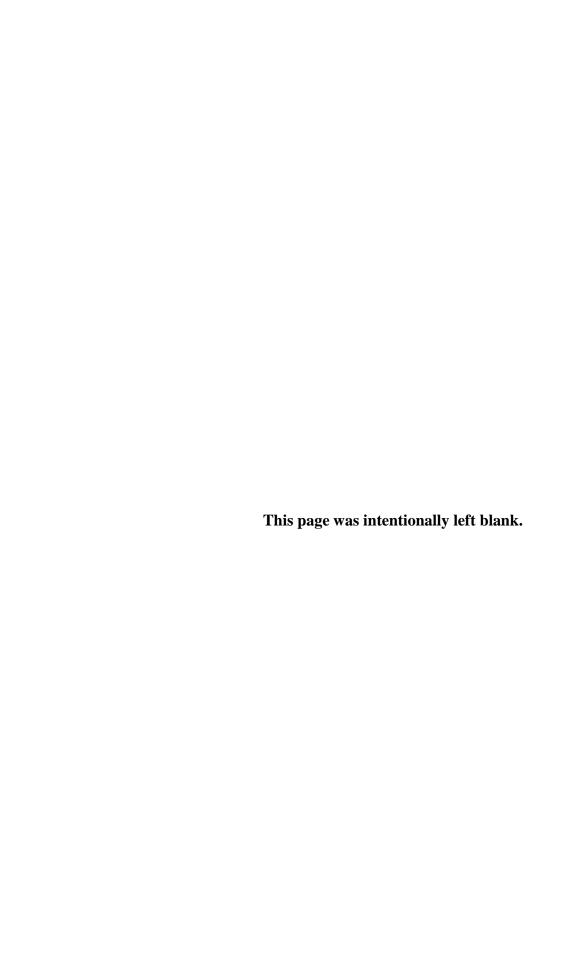

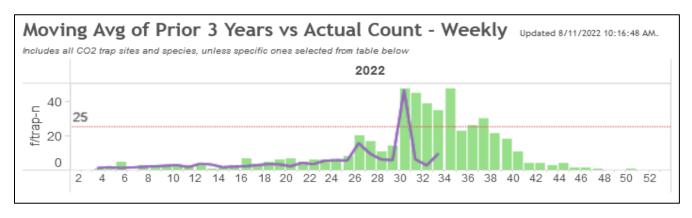
Adult Mosquito Abundance

- During July, the abundance of *Culex tarsalis* peaked the week of July 10 (week 29, figure 1) and has been steadily decreasing. This peak is about 3 weeks earlier than the 3-year average.
- Adult *Culex pipiens*, which primary sources include catch basins and log decks, counts also peaked in July and is currently trending below the 3-year average (Figure 2).

Operations

Aerial Larvicide Treatments

- Our last aerial liquid larvicide application is scheduled for August 16.
- On July 28, the last aerial granular larvicide application on organic rice fields was completed for this season.



Aerial Adulticide Treatments

 Thus far this season, in response to high abundance of adult *Culex tarsalis* and positive West Nile virus mosquitoes, we made 8 aerial adulticide ultra-low volume (ULV) applications, over 73,00 acres of rural western Placer County.

• Ground Adulticide Treatments

 In response to high abundance of adult Culex tarsalis and positive West Nile virus mosquitoes, we treated over 3,300 acres with 9 ground adulticide truck applications.

• Catch Basin treatments

 In the month of July we treated approximately 6,000 catch basins. Catch basins are a primary source of Culex pipiens, one of our main vector species and a potential source for Aedes aegypti.

• Unmanned Aircraft Systems (UAS)

o The UAS team completed 4 larvicide applications to organic rice totaling 182 acres treated.

Fisheries & Biological Control

In the month of July, Vector Control Technicians stocked 54 mosquito larval sites, totaling in over
 1,225 mosquitofish (*Gambusia affinis*).
