### **Background:**

Based on consistent performance and cost. The District has selected adulticides, Dibrom™ and Evergreen Air 5-25™ for use in our mosquito adulticide program, and Valent Bioscience's biorational larvicide (Bti) products for use in our mosquito larvicide program. Azelis is the sole source vendor for Valent Bioscience larvicide and for Dibrom™ and Evergreen adulticides.

Azelis is offering a 2.5% discount for Vectobac (Bti) larvicide products used by the District for larval control of mosquito in irrigated rice fields and other areas of standing water. Reign is an adjuvant used to prevent evaporation when applying liquid Vectobac 12 AS.

Board Review and Consideration to Purchase Replacement UAS for Mosquito Control Applications

### **Background:**

The District requires replacement of our unmanned aircraft used to apply mosquito control products. Our existing spray drone (DJI AGRAS MG-1s) has been in service since 2017 and recently developed a problem with the map in the controller following a firmware update. This seems to be a widespread problem with this make and model and seems to be related to its being at end of life. Please see staff report from Scott Schon, attached.

It is critical to have a U.S. made <55lb spray drone this season to do the following:

- 1. Treat rice and other areas with mosquito larvicide that are difficult to access or need additional treatments.
- 2. Test a new mosquito adulticide sprayer that we are working to develop with an agricultural engineering firm that will likely get funded by a federal grant (Deployed Warfighter Protection Program).
- 3. Anticipate increasing concern over use of foreign UAS by government agencies and look at shifting spray drones to US-made NDAA-compliant models.

We have done some significant research and there is only one small spray drone that meets our needs, the Hylio AG-110. Hylio is a sole source for the agricultural spray drone of this size that we require. We have received a quote for \$21,240 + tax for a complete system. They require 50% down to start production with a lead time of 12 weeks. We have funds for this purchase in our capital fund, however we did not budget for this specifically in the current budget.

The attached quotation also includes pricing for a larger spray drone, AG 130, which increases the capacity of operations in rural areas such as agricultural fields. We anticipate recommending, purchase of the larger UAS in addition to the smaller one in a future fiscal year.

### **Fiscal Impact:**

Funds for equipment replacement are available in the capital asset designation.

### **Staff Recommendation:**

Staff recommends that the Board authorize the District General Manager to purchase the Hylio AG-110 UAS system as presented not to exceed \$25,000.

Recommendation for new Spray Drones

Prepared by Scott Schon

In December 2017 the District purchased its first spray drone, DJI AGRAS MG-1S. This unmanned aircraft system (UAS) was a great turnkey UAS, and one of the best options at the time. Over the last few years we have conducted many trials and treatments evaluating this technology in mosquito control, and quickly learned that UAS are valuable tools in helping us accomplish our mission.

According to the manufacture DJI, this system had a production suspension time of January 2018 and a service suspension time of January 31, 2023. At the first of the year, we noticed a failure in our maps loading on our UAS transmitter. As we dug deeper into the issue, we found that DJI updated their map services, and these new services were included in the new firmware v5.3.0.1. After downloading and installing the new firmware we discovered we lost the ability to zoom into the map to see our location. We have been working with DJI over the last month to find solutions, but they have offered up very little assistance as of today.

UAS remote pilots depend heavily on their maps when verifying location of aircraft, obstacle avoidance mapping, and spray block design. The vast majority of UAS applications (96%) are autonomous which require the pilot to place way points on the map of their remote to construct a spray block. With this no longer being an option, I recommend we ground the District's MG-1S for any future autonomous applications.

Over the last 6 years, like with most technology, spray drones have continued to progress and become even more technologically advanced then previous systems. We as end users have become more educated and have watched the industry grow and systems improve which has given us a good sense of what we want in a UAS.

Components of a new system would include things like a FPV camera to improve situational awareness, obstacle avoidance radar, customer service, remote ID compatible, and easy to use software to help with planning, treating, and reporting UAS applications. All things our current system is lacking, even when working properly.

With regulatory issues like the 2019 National Defense Authorization Act (NDAA) Section 889, and other states starting to ban drones made overseas we feel it is important to go with a US based company like Hylio Drones. Hylio <a href="https://www.hyl.io/">https://www.hyl.io/</a> is based in Texas where they build their own drones and write their own software. Being US-based and manufacturing a lot of their own parts in-house will help with the availability of spare parts as well as being able to get in touch with someone for customer service.

With our current system grounded and lacking a lot of the new safety features mentioned above I recommend replacing our DJI AGRAS MG-1S with at least one new Hylio UAS.

Board Review and Consideration to Amend the District Budget for Fiscal Year 2022-23

### **Background:**

The following amendments to the FY 22-23 budget are requested.

- 1. Parking lot maintenance and repair project at the Roseville facility was considered by the board under a separate agenda item. If approved, we request \$21,400 be allocated from Capital Asset Designation OT991007 Capital Assets (30210) to SC2861 Maintenance-Building (52161)
- 2. Replacement of the District's mosquito control application drone was considered by the board under a separate agenda item. If approved, we request \$25,000 be allocated from Capital Asset Designation OT991007 Capital Assets (30210) to SC2680 FA Aircraft and Airport Equipment (GL54450)
- 3. Replacement of the District's trailer used to transport a side-by-side UTV was considered by the board under a separate agenda item. If approved, we request \$7,000 be allocated from Capital Asset Designation OT991007 Capital Assets (30210) to SC5220 FA Trailers (GL54450)
- 4. The District keeps an emergency response designation to fund the first two seasons of a new invasive mosquito infestation, and to fund larger than average outbreaks of West Nile virus vectoring mosquito species. Our normal practice is to track emergency response costs as they occur, and replenish the current year's budget with funds from the emergency response designation as a budget amendment. We request \$79,744 be allocated from Emergency Response Designation OT991017 Other (30210) to the spend categories / ledger accounts shown on the attached spreadsheet.

### **Fiscal Impact:**

These proposed budget amendments draw funds from capital asset and emergency response reserves for unforeseen needs not included in the current FY 2022-23 budget.



## Field Operations and Surveillance Report Prepared March 13, 2023

### Mosquito & Tick Surveillance

### Adult Mosquito Abundance

- Adult abundance traps continue to collect low amounts of mosquitoes, while numbers are still low, both abundance and species diversity should start increasing when the rain decreases, and day and nighttime temperatures increase.
- We are planning to begin our peak season trapping schedule starting the first week in April, though this is dependent on weather and staffing resources.

### • Vector-borne Disease Testing

- To ensure quality control and consistency of disease testing among local agencies' labs, a profiency panel is provided annually by Davis Arbovirus Research and Training (DART). The results of this panel are reviewed and published by DART, and if results are not sufficently similar to the reference results, DART works with the local lab to ensure that disease testing labs meet minimum sensitivity and accruracy benchmarks.
- Senior Research Scientist Phil Spinks has nearly completed the District's panel. Once submitted, we expect results from DART within a couple weeks.

### Field Operations

#### Arena Air 2023: Aerial larvicide contract

 Russ Stocker has returned the 2023 aerial larvicide contract, it is expected to be reviewed and completed by March 17.

### Aerial and Ground product and equipment calibration:

- Arena Air: Aerial larvicide calibration is scheduled for the third week of April. Two fixed winged aircrafts will be calibrated for liquid and granular products.
- Truck Adulticide: Dennis Candito, a representative from Azelis, will be onsite in April to characterize droplet sizes for our truck mounted and handheld adulticide equipment.

- As chair of the Unmanned Aerial Systems (UAS) subcommittee, I submitted the attached UAS report to the AMCA board.
- I am currently working with Drone attorney Jonathan Rupprecht and the FAA to establish a special collaboration between the FAA innovation office and the AMCA to potentially establish nationwide exemptions to conduct mosquito control drone missions.

### AMCA Legislative and Regulatory Committee UAS subcommittee Report Joel Buettner, UAS subcommittee Chair February 9, 2023

The UAS subcommittee has not met in quite a while, however my goal is to re-establish regular communications moving forward. There are several priorities that affect the current and future use of UAS in mosquito control from regulatory, technological, and operational perspectives.

### Remote ID

This is the most pressing issue for agencies and their pilots who operate UAS regardless of what regulations (civil or public aircraft). **As of September 16, 2023, all drone pilots must meet the operating requirements of Part 89.** For most operators this will mean flying a Standard Remote ID Drone or equipping with a broadcast module.

For spray drones, the only models that have gained a declaration of compliance to operate as standard remote ID are the DJI T-30 and T-40 as of this writing. Drone manufacturers must apply to the FAA for a declaration of compliance specific drone models to be deemed standard remote ID compliant. The list of aircraft declaration of compliance can be found at <a href="https://uasdoc.faa.gov/listDocs">https://uasdoc.faa.gov/listDocs</a>

For UAS models that do not have an approved declaration of compliance, operators can comply by attaching a remote id broadcast module. The first broadcast module and associated app approved for use by the FAA is made by <a href="DroneTag">DroneTag</a> and costs several hundred dollars. There may also be other brands approved now and in the near future. Pilots are responsible for ensuring that their aircraft is compliant with remote ID and any equipment attached does not compromise the safe operation and airworthiness of their aircraft.

### **UAS in Mosquito Control Guidelines Document**

AMCA support of the development of a guidelines document for use of UAS in mosquito control has been discussed for some time. The Mosquito and Vector Control Association of California's (MVCAC) drone committee is currently working on parts of such a document which would tentatively include the following sections:

- 1. Introduction
- 2. UAS Mission Types that Support Integrated Mosquito Management
- 3. Relevant UAS Regulations
- 4. Best Practices for Operating UAS for Mosquito Control
- 5. Considerations For Starting a UAS Program
- 6. Mosquito UAS Mission Database

This manual will serve as a foundation for setting an industry standard for UAS use in mosquito control, and may be leveraged to gain mosquito control specific exemptions or other regulatory compliance for industry specific operations such as flying beyond visual line of sight, operating over 400', and gaining airspace authorization in difficult areas.

### **Regulatory Issues**

Since several desirable UAS mission types have some regulatory hurdles to overcome, we are looking into collaborating with federal regulatory agencies to identify solutions to some of these hurdles. The main issues lie with either the FAA or the EPA related to pesticide label language for UAS applications. FAA – related issues

- Spraying with a 55+lb UAS within 500 feet of structures, non-participating people, roads, or vehicles is
  prohibited when operating under Part 137 rules. Some exemptions have been granted to lessen this buffer
  to 100' if the pilot meets a certain number of flight hours, but without a complete waiver of this buffer
  requirement, the use of 55+lb UAS is severely limited in areas with bordering structures or roads.
- Beyond visual line of sight (BVLOS) operations is becoming more commonly granted as an exemption in many industries. For mosquito control being able to operate BVLOS more than "briefly" requires special authorization. As mosquito control operations become more complex and larger scale, BVLOS operations will become necessary. Currently only Standard RID UAS qualify for an exemption permitting BVLOS.
- Flying over residential areas to look for unmaintained swimming pools. Triggers several concerns such as: line of sight operations is difficult to maintain in developed areas, <400' altitude may create some privacy concerns based on existing case law, and flying over structures, roads, and non-participating people is generally prohibited.
- Spraying adulticides from a <55lb UAS may require brief operation near or over structures, roads, vehicles, and non-participating people. Aside from the pesticide label concerns, simply operating the UAS in the places and at the altitudes necessary for a safe and effective mosquito adulticide application is potentially problematic.

### EPA-related issues

- Unmanned Aerial Adulticide Applications are generally allowed by the FAA as long as the application is
  authorized by the pesticide label (<u>Part 137.39</u>). Our understanding from the EPA is that unmanned
  applications are allowed if the application can comply with the approved aerial application label language
  and the registrant is in agreement that unmanned aerial application is consistent with the label.
- US EPA has stated that for UAS-specific pesticide label language to be approved, a pesticide risk assessment
  is required and has traditionally required the use of the AGDISP model. Unfortunately, the AGDISP model is
  not compatible with multi-rotor aircraft, and therefore is unable to be used to evaluate pesticide
  applications from multi-rotor unmanned aircraft.
