A RESOLUTION OF THE BOARD OF TRUSTEES OF THE PLACER MOSQUITO AND VECTOR CONTROL DISTRICT APPROVING THE ENGINEER'S REPORTS, CONFIRMING THE ASSESSMENT DIAGRAM AND ASSESSEMENT AND ORDERING THE LEVY OF ASSESSMENTS FOR FISCAL YEAR 2023-24 FOR THE MOSQUITO CONTROL DISTRICT AND THE EAST COUNTY MOSQUITO CONTROL AND DISEASE PREVENTION DISTRICT

WHEREAS, the Placer Mosquito and Vector Control District (formerly known as the Placer Mosquito Abatement District, the "District") is authorized, pursuant to the authority provided in Health and Safety Code Section 2082 and Article XIIID of the California Constitution, to levy assessments for mosquito, vector and disease control projects and services; and

WHEREAS, such vector surveillance and control projects and services provide tangible public health benefits, reduced nuisance benefits and other special benefits to the public and properties with the areas of service; and

WHEREAS, an assessment for mosquito, vector and disease control projects and services has been given the distinctive designation of the "Mosquito Control District" ("Assessment"), and is primarily described as encompassing the boundaries of West Placer County, and an assessment for mosquito, vector and disease control projects and services has been given the distinctive designation of the "East County Mosquito Control and Disease Prevention District" ("Assessment"), and is primarily described as encompassing the boundaries of East Placer County; and

WHEREAS, the Assessment was authorized by an assessment ballot proceeding conducted in 2000 for the Mosquito Control District and in 2004 for the East County Mosquito Control and Disease Prevention District and approved by a majority of the weighted ballots returned by property owners, and such assessments were levied by the Board of Trustees of the Placer Mosquito and Vector Control District.

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of the Placer Mosquito and Vector Control District that:

- 1. SCI Consulting Group, Inc., the Engineer of Work, prepared an engineer's report in accordance with Article XIIID of the California Constitution and Section 2082, et. seq., of the Health and Safety Code for the Assessment (the "Report"). The Report has been made, filed with the secretary of the board and duly considered by the Board and are hereby deemed sufficient and preliminarily approved. The Report shall stand as the Engineer's Report for all subsequent proceedings under and pursuant to the foregoing resolution.
- 2. On May 15, 2023, this Board adopted Resolution No. 2023-05 to continue to levy and collect Assessments for fiscal year 2023-24, preliminarily approving the Engineer's Report, and providing for notice of hearing on July 17, 2023 at 4:00 o'clock p.m. at 2021 Opportunity Drive in Roseville, California.
- 3. At the appointed time and place the hearing was duly and regularly held, and all persons interested and desiring to be heard were given an opportunity to be heard, and all matters and things pertaining to the levy of Assessment were fully heard and considered by this Board, and all oral statements and all written protests or communications were duly heard, considered and overruled, and this Board there by acquired jurisdiction to order the levy of assessment prepared by and made a part of the Engineer's Report to pay the costs and expenses thereof.
- 4. The above recitals are true and correct.
- 5. The public interest, convenience and necessity require that the levy be made.

- 6. The Engineer's Report for the Assessment together with the proposed assessment roll for fiscal year 2023-24 is hereby confirmed and approved.
- 7. Based on the oral and documentary evidence, including the Engineer's Report offered and received at the public hearing, the Board expressly finds and determines that: (a) each of the several lots and parcels of land subject to the Assessment will be specially benefited by the services to be financed by the assessment proceeds in at least the amount of the assessment apportioned against such lots and parcels of land, respectively; and (b) that there is substantial evidence to support, and the weight of the evidence preponderates in favor of, said finding and determination as to special benefit to property from the mosquito, vector and disease control services to be financed with assessment proceeds.
- 8. Assessments for fiscal year 2023-24 shall be levied at the rate of TWENTY-ONE DOLLARS AND SEVENTY-SIX CENTS (\$21.76) per single-family equivalent benefit unit as specified in the Engineer's Report for fiscal year 2023-24 with estimated total annual assessment revenues as set forth in the Engineer's Report.
- 9. The mosquito and disease control services to be financed with assessment proceeds described in the Engineer's Report are hereby ordered.
- 10. No later than August 10th following such adoption, the Board shall file a signed copy of this resolution with the Auditor of the County of Placer ("County Auditor"). Upon such filing, the County Auditor shall enter on the County assessment roll opposite each lot or parcel of land the amount of assessment thereupon as shown in the assessment. The assessments shall be collected at the same time and in the same manner as County taxes are collected and all the laws providing for collection and enforcement shall apply to the collection and enforcement of the assessments. After collection by the County, the net amount of the assessments, after deduction of any compensation due the County for collection, shall be paid to the Mosquito and Disease Control Assessment.
- 11. All revenues from Assessments shall be deposited in a separate fund established under the distinctive designation of the Placer Mosquito and Vector Control District.
- 12. The Assessment, as it applies to any parcel, may be corrected, cancelled or a refund granted as appropriate, by order of the Board of Trustees of the District. Any such corrections, cancellations or refunds shall be limited to the current fiscal year.

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE PLACER MOSQUITO AND VECTOR CONTROL DISTRICT APPROVING THE ENGINEER'S REPORTS, CONFIRMING THE ASSESSMENT DIAGRAM AND ASSESSEMENT AND ORDERING THE LEVY OF ASSESSMENTS FOR FISCAL YEAR 2023-24 FOR THE EXPANDED SERVICES AND PERMANENT FACILITY ASSESSMENT

WHEREAS, the Placer Mosquito and Vector Control District (formerly known as the Placer Mosquito Abatement District, the "District") is authorized, pursuant to the authority provided in Health and Safety Code Section 2082 and Article XIIID of the California Constitution, to levy assessments for mosquito, vector and disease control projects and services; and

WHEREAS, such vector surveillance and control projects and services provide tangible public health benefits, reduced nuisance benefits and other special benefits to the public and properties with the areas of service; and

WHEREAS, prior to 2008, the District facility was located on Waverly Drive in Lincoln, California and this facility was inadequate for virtually all elements of comprehensive mosquito and vector control including: laboratory work, legally compliant chemical storage, vehicle maintenance and storage, and general district management and administration, and the District was in need of a permanent vector control facility and laboratory; and

WHEREAS, as of 2007, in order to provide the level of vector control services desired by the community, the District needed to expand and improve its' vector control services; and

WHEREAS, on July 16, 2007, by its Resolution No. 2007-10, the Board approved the formation and levying of assessments of the Expanded Services and Permanent Facility Assessment pursuant to the provisions of Health and Safety Code section 2080 and the provisions of California Constitution Article XIII-D; and

WHEREAS, the purpose of the Assessment District is for the installation, maintenance and servicing of improvements to the Placer Mosquito and Vector Control District. Within the District, the proposed improvements and services are generally described as the expansion and improvements of mosquito and vector control services, surveillance, disease prevention, abatement, and control of vectors within the service area. Such vector control and disease prevention projects and programs include, but are not limited to, source reduction, biological control, disease monitoring, public education, reporting, accountability, research and interagency cooperative activities. The proposed improvements and services would also be the capital costs, maintenance, and operation expenses of a permanent operational vector control facility including laboratory and shop, as well as financing costs for the facility improvements and other capital improvements.

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of the Placer Mosquito and Vector Control District that:

- 1. SCI Consulting Group, Inc., the Engineer of Work, prepared an engineer's report in accordance with Article XIIID of the California Constitution and Section 2082, et. seq., of the Health and Safety Code for the Assessment (the "Report"). The Report have been made, filed with the secretary of the board and duly considered by the Board and are hereby deemed sufficient and preliminarily approved. WHEREAS, such tax report and proposed budget have been prepared and brought to the Board this date for consideration.

NOW, THEREFORE BE IT RESOLVED that the Board of Trustees of the Placer Mosquito and Vector Control District hereby approve and authorize the Lincoln Special Tax – 2023 Tax Report, as presented to the Board this day, to be submitted to Placer County to initiate the tax collection provisions at the general rate of FIFTEEN DOLLARS AND ZERO CENTS (\$15.00) per parcel, as indicated in the report; and

BE IT FURTHER RESOLVED, that the General Manager is hereby authorized and directed, on behalf of the District and in its name, to execute and deliver such documents and to do such acts as may be deemed necessary or appropriate to accomplish the intentions of this resolution.

Board Review and Consideration to purchase a Hylio AG-230 Unmanned Aircraft System.

Background:

The District has been pioneering the use of unmanned aircraft systems (UAS), commonly known as drones in mosquito control since 2016, and is working to upgrade its UAS to improve the efficacy and efficiency of mosquito larviciding and adulticiding over the next five years. As of February 2023, the district's first generation of spray drone, DJI AGRAS MG-1s, is being phased out of field use due to it being at end-of-life and no longer supported by the manufacturer. As a result of this, we have lost software capabilities such as the ability to view maps on the controller that makes continued use of this system unsafe

In March 2023, the District ordered the first of two planned UAS to replace the DJI AGRA MG-1s. The Hylio AG-210, which is a classified as a small spray drone (under 55 lbs. gross takeoff weight) and has a payload of 22 lbs and is expected to be delivered in September 2023. Small drones can legally operate in areas that large drones (55 lbs. and over) are not able to. While the Hylio AG-210 will be used to treat smaller areas in closed proximity to structures, roads, or people, and to support research and development of a UAS based mosquito adulticide capability, its limited payload makes it less efficient for large areas such as rice fields and pastures.

The second UAS we propose the purchase of is the Hylio AG-230 which has a payload of 43lbs. and if ordered in July, would arrive around December 2023. This larger UAS can more effectively treat larger areas such as small rice fields, pastures, or other rural areas. This will allow the district to better tailor larvicide applications to address specific hot spots that may need additional treatment or would be less economical to do with the manned aircraft.

Together, the smaller AG-210 and the larger AG-230 will be able to provide district operations the capability to respond more quickly with greater precision to prevent and manage mosquitoes in rural and urban habitats. While large scale treatments using manned aircraft will still be necessary for the foreseeable future, we expect UAS treatments to augment or enhance manned aircraft applications especially in remote rural communities, and in urban rural interface areas.

Fiscal Impact:

Please see the attached quote for the Hylio AG-230 in the amount of \$45,300 plus tax which equals \$48,677.50. Purchase of the Hylio AG-230 would be a capital expense funded from the district's capital designation. If approved, a budget amendment would be presented to the board for approval to appropriate funds from the capital designation to the proper spend account.

Staff Recommendation:

Staff recommends the board approve the purchase of the Hylio AG-230 UAS using capital designation funds not to exceed \$50,000.

Board Review and Consideration to Purchase Replacement Hand Foggers

Background:

The District needs to replace three aging London Fog hand foggers which are regularly used to treat small localized adult mosquito infestations during service requests. The district's current aging London Colt hand foggers are nearly 20 years old and are becoming increasingly difficult to calibrate and maintain. Staff have spent time evaluating several available types of hand foggers available on the market and specifically requested the purchase of new London Fog Colt4 gas-powered hand foggers to replace old models.

Fiscal Impact:

Please see the attached quote for three London Fog Colt4 hand foggers in the amount of \$12,671.40 including tax. Because each fogger is less than the capital asset threshold of \$5000, this equipment would not be considered a capital asset, however we propose to use funds from the district's capital designation. If approved, a budget amendment would be presented to the board for approval to appropriate funds from the capital designation to the proper spend account.

Staff Recommendation:

Staff recommends the board approve the purchase of three London Fog Colt4 hand foggers using capital designation funds not to exceed \$12,672.





Mosquito Surveillance & Vector-borne Disease Testing

Adult Mosquito Abundance

- During June and beginning of July, the abundance of *Culex tarsalis*, which primarily breeds in the rice fields, substantially increased (Figure 1), both aerial adulticide and larvicide applications were made to help control the abundance of *Culex tarsalis* and the spread of West Nile virus.
- Figure 2 shows a decrease of *Culex pipiens* during weeks 26-28 (June 25- July 10). This decrease
 is mainly due to our truck adulticide and additional larvicide applications within the Lincoln log
 decks in response to finding WNV positive mosquito samples.





Figure 3: Culex pipiens adult mosquito count per trap night (purple line), compared to the three-year average (green bars) by calendar weeks. (Week 28 represents July 2-15)





• Invasive Mosquitoes

- o In addition to the June 13 detection of invasive *Aedes* in the Cherry Glen neighborhood in Roseville, we have also detected invasive *Aedes* in the adjacent neighborhood of Thieles Manor.
- These detections further confirm an endemic population of Aedes aegypti in these neighborhoods.
- Door to door inspections, additional trapping and adulticide and larvicide applications are being performed in response.

Vector-borne Disease Testing

- Mosquitoes: 14 WNV positive mosquito samples (*Cx. tarsalis*) out of 559 tested have been detected in 2023.
- Dead Bird: Three positive birds (WNV) out of 64 tested have been detected in 2023.

Operations

Source Work

- In the month of June, Vector Control Technicians completed 129 service requests (75% within one day, 93% within 3 days).
- Made 731 treatments to both adult and larval mosquito sources, including 1 UAS larvicide application.

• Aerial Larvicide Treatments

 In June, we started weekly aerial larvicide treatments to all organic and conventional rice fields in Placer County with the goal of reducing mosquito production across the county. As we move forward in the season, we will adjust treatment areas based on proximity to population, disease detection, and mosquito abundance. This will allow us to focus resources to higher priority areas.

Aerial Adulticide Treatments

- In response to high abundance of adult Culex tarsalis and positive West Nile virus mosquitoes, two separate nights of aerial adulticide ultra-low volume (ULV) applications were made in Placer County.
 - Applications included the areas of Lincoln, Elverta and the West Roseville neighborhoods of West Park, Sun City, Sierra Vista, and rural agriculture areas of west Placer County.



Ground Adulticide Treatments

o In response to high abundance of adult *Culex tarsalis*, positive West Nile virus mosquitoes, and invasive *Aedes* detections ground adulticide truck applications were made on three separate days to areas of Lincoln, rural agricultural of western Placer and the Roseville neighborhoods of West Park, Theiles Manor, and Cherry Glen.

• Catch Basin Treatments

On July 10, field technicians started second round of inspecting and treating approximately 6,000 catch basins. Catch basins are a primary source of *Culex pipiens*, one of the major vectors of WNV.

• Fisheries & Biological Control

- In the month of June, Vector Control Technicians stocked 163 mosquito larval sites, totaling in over 3,193 mosquitofish (*Gambusia affinis*).
- Additional mosquitofish were harvested from local sources, and mosquitofish breeding has begun recently.
