The Auditor-Controller is pleased to confirm our understanding of the terms and costs of our services under this agreement for the 2024-2025 fiscal year.

A. Scope of Services

The Auditor-Controller will provide the following services to Placer County Mosquito and Vector Control District (District):

1. **General Accounting** – includes use of the County's centralized accounting system and recording of financial system entries submitted by the District. Transactions will be reviewed for authorization by appropriate District personnel prior to processing. This also includes compiling the District's financial information to report within the County's Cost Plan, if applicable.
2. **Accounts Payable** – includes processing payment claims by warrant, wire, or ACH. Claims will be reviewed to validate authorized District signers have approved the payment prior to processing, recording, and mailing payments. Any invoices submitted with payment claims will be scanned and archived for retention. Review of invoices for mathematical accuracy and appropriateness of expenditure is not part of the service agreement. Maintaining vendors and payments for purposes of tax reporting along with issuing IRS Tax Form 1099 for the calendar year, if applicable and biweekly State EDD Reporting.
3. **Payroll** – includes bi-weekly payroll processing and validating employees' timecards including wage garnishments, recording, and mailing payments, submitting retirement and deferred compensation data, remitting tax payments, filing quarterly tax reports, issuing W-2 forms, and maintaining complete records. All payroll will be reviewed by the District prior to submitting for payment.
4. **Workday External Connection** – includes access to the Workday accounting system.
5. **Financial Statements**- includes compiling the applicable fiscal year(s)' financial information into financial statements.
6. **Adopted Budget** – includes recording your District's adopted budget, ensuring expenditures do not exceed authorized budget and processing budget revisions.
7. **Gann Limit** - calculation of appropriation limit for the current fiscal year and measurement (testing) of appropriation limit for the previous fiscal year to assist the District in meeting the requirements of Article XIII B, Section 1.5 of the California Constitution.

B. Term

The term of this Agreement will commence on July 1, 2024, and end on June 30, 2025. Subject to written agreement of the parties, this agreement may be renewed annually.

C. Responsibilities of Auditor-Controller

The Auditor-Controller's responsibility under this Agreement is to perform the services enumerated above. The Auditor-Controller will not audit accounting entries, payment claims or budget transactions, nor will we validate the appropriateness of accounting transactions or claims for payment.

The Auditor-Controller's services are not designed to detect instances of fraud, noncompliance with laws or regulations or significant errors; however, the Auditor-Controller will communicate to District any known and suspected fraud, noncompliance with laws or regulations or significant errors that come to their attention. Neither the County nor the Auditor-Controller will be held liable should any instances of fraud, noncompliance with laws or regulations or significant errors be subsequently discovered by either District or through a claim or lawsuit to District.

D. Responsibilities of District Management

District is responsible for (1) ensuring all transactions are submitted and/or approved by authorized staff, (2) reviewing all transactions prior to submittal to ensure appropriateness of the expenditure, compliance with laws or regulations and to check for significant errors and fraud, (3) retaining all source documents, and (4) providing all District Board authorized budgets and budget amendments. The District is encouraged to routinely provide accounting reports and payment registers to its Board for review.

District agrees to inform County of significant noncompliance, fraud and/or errors immediately upon discovery.

For all services provided the District management agrees to assume all management responsibilities; oversee the services by designating an individual who possesses suitable skill, knowledge, and/or experience to understand the services; evaluate the adequacy and results of the services; and accept responsibility for the results of the services. District agrees to hold the County and the Auditor-Controller harmless for any subsequent claims or lawsuits that may arise from the results of the services.

Annual Cost and Billing

The annual cost of services identified above is \$16,330.67. Your District will be billed by journal entry during the third quarter of the fiscal year for the entire annual costs. Specific billing details can be provided to the district upon request.

Agreement

The Auditor-Controller appreciates the opportunity to be of service to you and believes this letter accurately summarizes the significant terms of your agreement. This Agreement constitutes the entire agreement between the parties and supersedes all prior agreements. Please execute this document and return the original version to my office at your earliest convenience.

Board Review and Consideration to Purchase a Replacement Laboratory Freezer

Background

The District's lab relies on two ultra cold (-80 degree F) freezers to store mosquito samples and preserve genetic material for follow-up disease testing and future research. One freezer is a stand up type that is used mostly for day to day use, and the other is a chest-type freezer used for long-term storage and knocking down mosquito samples from the field. The upright freezer was replaced this past year, and now the chest freezer is having problems cooling. This freezer is over 10 years old and even if it can be repaired, its lifespan is limited. To ensure we do not have impacts to lab operations this summer we recommend purchasing a replacement.

Fiscal Impact

This was not a budgeted expenditure; however, we have capital asset designation funds that can be used for equipment replacement. Staff have researched models of replacement freezers and have considered the lead time for delivery. We recommend purchasing a PHCbi TwinGuard® Series 25.3 Cu. Ft. -86°C ULT Chest Freezer with Dual Cool Refrigeration Technology (208/230V) from LABRepCo. Please see the attached price quote. If approved, and if the freezer is received before June 30, a budget amendment will be presented at the July Board meeting to fund this purchase from the current FY 23-24 budget. If the freezer is received after June 30, we will amend the FY 24-25 budget accordingly.

Staff Recommendation:

Staff recommends purchasing a PHCbi TwinGuard® Series 25.3 Cu. Ft. Ultra Cold Freezer from LAB Rep Co. as presented not to exceed \$20,000.

FOR TAX YEAR 2024-25**

DIRECT CHARGE NAME: Placer Mosquito and Vector Control

WHEREAS, the Placer Mosquito and Vector Control District (hereinafter "District") requests the County of Placer collect on the County tax rolls certain charges which have been imposed pursuant to the Government Code, the Health and Safety Code and Article XIIC and XIID of the California Constitution by the District, attached hereto, and

WHEREAS, the County has required as a condition of the collection of said charges that the District warrant the legality of said charges and defend and indemnify the County from any challenge to the legality thereof; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of District as follows:

1. The Auditor-Controller of Placer County is requested to attach for collection on the County tax rolls those taxes, assessments, fees and/or charges, attached hereto.
2. The District warrants and represents that the taxes, assessments, fees and/or charges imposed by the District and being requested to be collected by Placer County comply with all requirements of state law, including but not limited to Articles XIIC and XIID of the California Constitution (Proposition 218).
3. The District releases and discharges County, and its officers, agents and employees from any and all claims, demands, liabilities, costs and expenses, damages, causes of action, and judgments, in any manner arising out of the collection by County on the property tax roll of any taxes, assessments, fees and/or charges on behalf of District.
4. In consideration for the County's collection of the charge through the County's property tax roll, the District agrees to and shall defend, indemnify and hold harmless the County, its officers, agents and employees (the "Indemnified Parties") from any and all claims, demands, liabilities, costs and expenses, damages, causes of action, and judgments, in any manner arising out of the collection by County of any of District's said taxes, assessments, fees and/or charges requested to be collected by County for District, or in any manner arising out of District's establishment and imposition of said taxes, assessments, fees and/or charges. District agrees that, in the event a judgment is entered in a court of law against any of the Indemnified Parties as a result of the collection of one of District's taxes, assessments, fees and/or charges, the County may offset the amount of the judgment from any other monies collected by County on behalf of District, including property taxes.

5. The District agrees that its officers, agents and employees will cooperate with the County by responding to all inquiries referred to District by County from any person concerning the District's taxes, assessments, fees and/or charges, and that District will not refer such persons to County officers and employees for response.
6. The District agrees to pay the County for the reasonable and ordinary charges to recoup its costs of placement and collection on the tax rolls at the agreed upon rate of 1% of the taxes, assessments, fees and/or charges, as provided by Government Code sections 29304 and 51800.

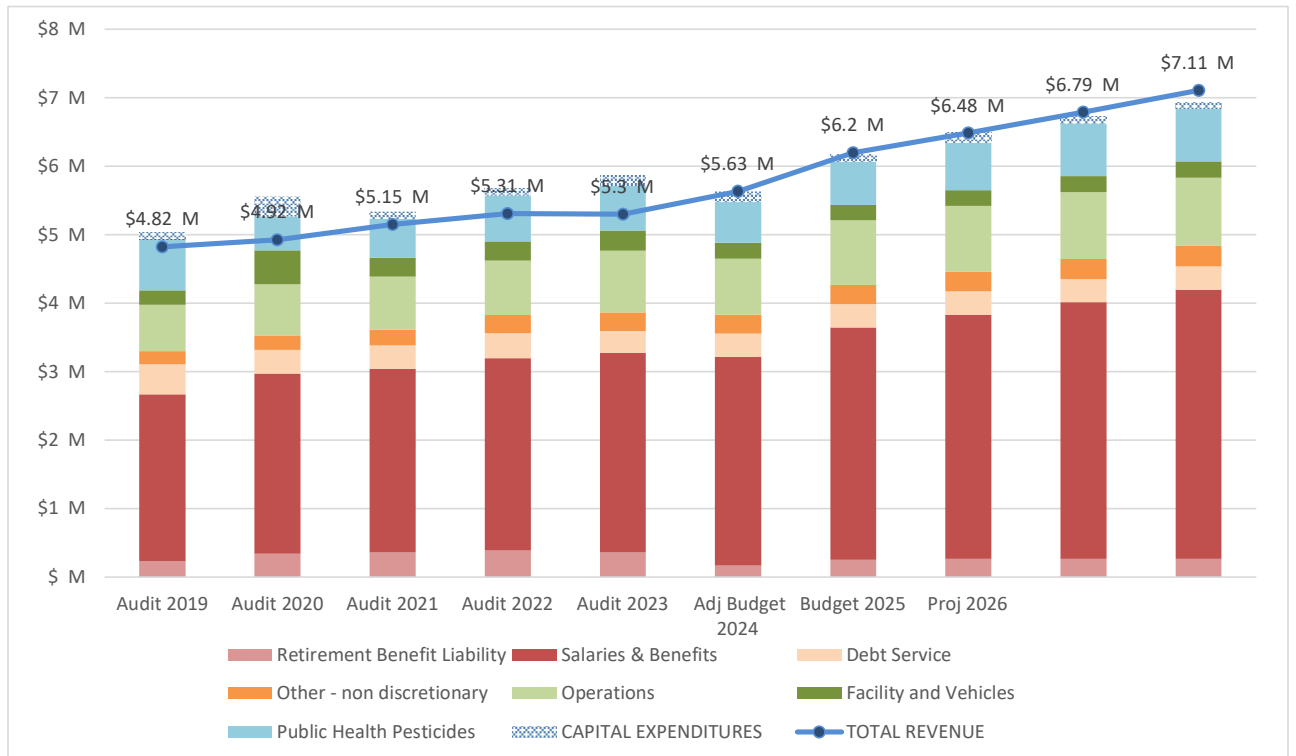

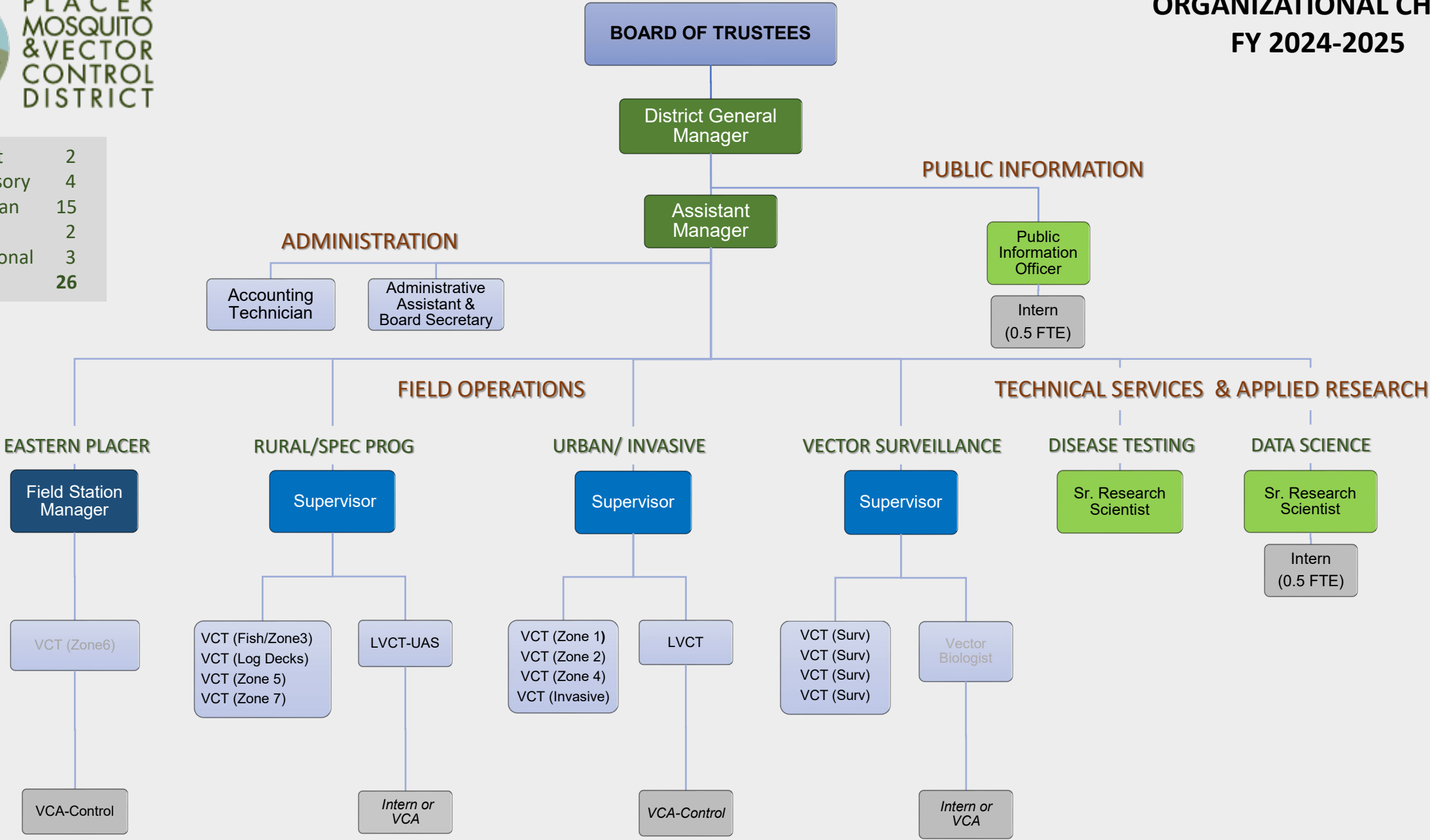

Board Review and Consideration of FY 2024-25 Capital Budget and Resolution 2024-10 Amending the FY 24-25 District Budget

Background

As discussed in the Finance Committee, the Capital Budget for FY 2024-2025, attached, includes planned capital expenditures for the following purchases:

1. Replacement of the District's F250 flatbed truck. This truck is used to perform wide area larviciding to manage invasive mosquito infestations and during larger scale UAS operations as part of a rolling launch site. Recently, this vehicle had mechanical issues which are being assessed. Even if repairable, the District will be required to replace or retire this vehicle to comply with current CARB regulations affecting larger fleet vehicles.
2. Purchase of a Hyllo AG-210 UAS. This purchase was previously approved by the board in May 2024, and has been ordered. Because we will not receive this UAS until August 2024, we include it here as part of the FY 24-25 capital budget.
3. Purchase of an additional Ford F150 technician vehicle. One field technician is currently using a vehicle typically used for seasonal staff. By purchasing an additional Ford F150 (or equivalent vehicle) we can continue to use the older vehicle for seasonal staff.

Fiscal Impact:

The total capital expenditures for the items above are estimated to not exceed \$130,000 which would be appropriated to the FY 24-25 budget from the Capital Asset designation by budget amendment, attached. Any left-over funds appropriated will be returned to the Capital Asset designation at the end of the fiscal year.

Staff Recommendation:

1. Staff recommends the Board accept and approve the FY 24-25 Capital Budget.
2. Staff recommends the Board approve Resolution 2024-10 Amending the FY 24-25 Annual Budget as presented.

WHEREAS, the measure limits the ability of the Placer Mosquito and Vector Control District to plan and respond timely to emerging needs including increasing invasive mosquito infestations and threats of local transmission of vector-borne diseases not previously found in our jurisdiction.

WHEREAS, the measure limits voters' rights, containing undemocratic provisions that would make it more difficult for local voters to pass measures to fund services, provisions that retroactively cancel measures recently passed by local voters, and provisions that prevent voters from passing advisory measures that provide direction on how they want their local tax dollars spent; and

WHEREAS, the measure restricts the discretion and flexibility of locally elected boards to respond to the needs of their communities, and injects uncertainty into the financing and sustainability of critical infrastructure; and

WHEREAS, the measure constrains state and local officials' ability to protect our environment, public health and safety, and our neighborhoods against those who violate the law; and

WHEREAS, the measure is opposed by hundreds of local governments, firefighters and other first responders, healthcare providers, teachers, working families, and local elected officials.

THEREFORE, BE IT RESOLVED that the Placer Mosquito and Vector Control District opposes Initiative 1935 (formerly 21-0042A1);

BE IT FURTHER RESOLVED, that the Placer Mosquito and Vector Control District will join the No on Initiative 1935 (formerly 21-0042A1) coalition, a growing coalition of local government, public safety, labor, infrastructure advocates, and other organizations throughout the state.

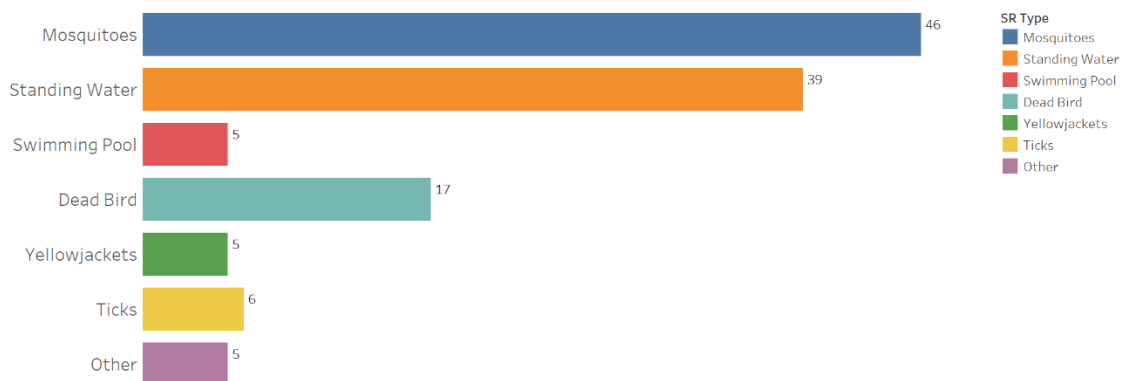

There was a decrease in service requests in May compared to April. There was an increase in dead bird reports.

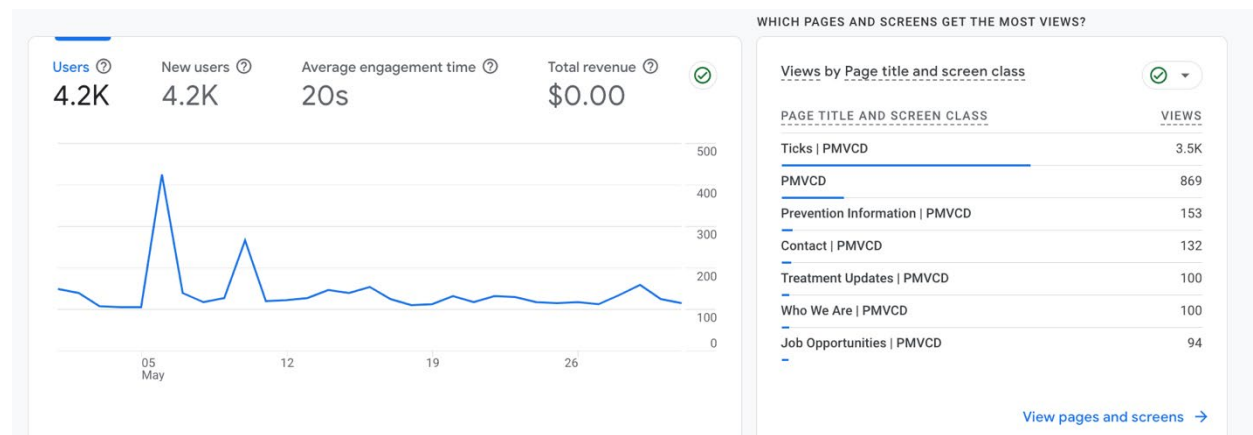

Increase Grasshopper Activity in Placer County



Beginning Friday, May 31, we started to hear from the public about grasshopper issues in west Placer including West Roseville and Lincoln. By Monday, had taken close to 12 service requests. The calls have continued throughout the week. We initiated contact with other organizations that were receiving calls about the issue and drafted frequently asked questions so all agencies could share a unified response with the public. Below is the latest draft of the response.

The Placer County Agricultural Commissioner in collaboration the UC Urban and Community Integrated Pest Management Area Advisor, the UC Master Gardeners of Placer County, Placer Mosquito and Vector Control District, and the cities of Roseville and Lincoln, worked together to answer some frequently asked questions.

WHAT

What species of grasshoppers are being found in Roseville and Lincoln?

The grasshoppers being found in West Roseville and Lincoln have been identified as short-horned *Melanoplus* spp. grasshoppers.

The young grasshoppers (called “nymphs”) emerge from the soil in late spring, commonly in pastures or field environments. *Melanoplus* grasshoppers are general feeders and consume a wide variety of plants. They prefer young green plants and enjoy consuming lettuce, beans, corn, carrots, onions, and some annual flowers. They dislike tomatoes and squash, so your tomato plants are safe unless there are no other food options nearby. The nymphs molt (shed their skin) five times over about two months before developing into winged, flying adults.



WHY

Has the county ever experienced something like this before?

In most years, these grasshoppers go unnoticed, but when conditions are favorable such as warm, moist springs when abundant food is produced, populations may increase dramatically. Adult or nymphal grasshoppers may migrate into surrounding areas in search of more food. Severe outbreaks only occur every eight to ten years and can last a couple of years. When wild food becomes depleted (i.e. grasses dry up in rangelands), grasshoppers migrate into neighborhoods and landscaped areas in search of food. Landscape plants can be a desirable food source for grasshoppers. Luckily, garden damage is usually limited to a few weeks in early summer, immediately after rangeland plants dry up.

PREVENTION

What can we do to help with the grasshopper activity and mitigate impacts to our yards and plants?

Unfortunately, once large numbers of grasshoppers are present in residential landscaping, control options are very limited. Individual plants may be protected by covering them with screens or cloth. However, grasshoppers will eat through cloth or plastic screen if hungry enough. Metal window screen is resistant to grasshopper mouthparts. A successful screening strategy could include screening your most desirable plants and leaving other plants available for grasshoppers to eat. Grasshopper populations may be reduced by manually removing insects through sweeping or raking and bagging for disposal. However, physical removal may not be effective for large grasshopper populations and will require ongoing removal to control.

The optimal time for insecticide application is when grasshopper nymphs are in fields because control with insecticides becomes difficult after grasshoppers have migrated into the garden. Insecticides are generally ineffective against grasshoppers in the landscape because of low residual activity of only a few days. Read the product label to determine the allowable frequency of application. Irrigation or rain can wash away insecticides and further reduce the effectiveness. Insecticide application endangers bees and other beneficial insects; therefore, it is important to ensure insecticides are sprayed on pollinator plants. Grasshoppers' natural predators are birds, blister beetles, and robber flies.

Mosquito Surveillance & Vector-borne Disease Testing

- **Adult Mosquito Abundance**
 - We continue to collect a high diversity of mosquito species and expect our vector species, such as *Culex tarsalis* and *Culex pipiens*, to also start increasing in abundance.
- **Vector-borne Disease Testing**
 - Thus far in 2024, there have been no WNV detections in Placer County.

- **Invasive *Aedes*:**
 - New invasive detections:
 - On May 30th, we detected our first 2024 *Aedes aegypti* mosquitoes in the Foothill Junction neighborhood in Roseville, a new location for us. We are currently assessing the extent of the *Ae. aegypti* population.
 - Wednesday June 5, *Aedes aegypti* mosquito was detected in the Parker Whitney neighborhood of Rocklin near Johnson-Springview Park
 - In response, technicians are following our invasive response plan, including providing residents with educational information, setting traps to determine the extent of the detection, searching and treating sources by hand and by vehicle.

Operations

- **Arena Air 2024: Aerial larvicide applications to rice.**
 - Larvicide treatments of Vectobac 12AS in the conventional rice fields started on June 10 and the treatments of VectoBac GR in the organic rice will start on June 24.



- Conventional rice decreased by nearly 2000 acres when compared to last year. While planted organic rice increased by 138 acres.

WEEKLY UPDATE

Humans

No human infections have been reported in 2024.

Dead Birds

A total of 2 new West Nile virus (WNV) positive dead birds were reported from 2 counties: Sacramento (1) and San Joaquin (1). **These are the first detections of WNV activity in Sacramento County and San Joaquin County this year.** In 2024, 19 WNV positive dead birds have been reported from 7 counties. At this time last year, 16 WNV positive dead birds had been reported from 5 counties.

Mosquito Pools

West Nile virus

A total of 27 new WNV positive mosquito pools were reported from 1 county: Riverside (27). In 2024, 52 WNV positive mosquito pools have been reported from 6 counties. At this time last year, 15 WNV positive mosquito pools had been reported from 7 counties.

St. Louis encephalitis virus

A single (1) new St. Louis encephalitis virus (SLEV) positive mosquito pool was reported from 1 county: Fresno (1). In 2024, 2 SLEV positive mosquito pools have been reported from 1 county: Fresno (2). At this time last year, 2 SLEV positive mosquito pools had been reported from 2 counties.

Sentinel Chickens

No seroconversions have been reported in 2024.

General Manager's Report

- **Invasive Mosquito Response Plans** for the 2024 season are being updated in light of the multiple recent new detections in Rocklin and Roseville. These detections are much earlier in the season than we have seen in the past, which creates staffing concerns as we ramp up for the start of West Nile virus season at the same time. To help this, I have approved the recruitment of two additional temporary staff (Vector Control Assistants) to specifically assist with invasive mosquito response and surveillance as well as other duties as assigned. In addition, we are planning to purchase additional invasive mosquito traps and other supplies. I plan to work with staff and finalize what additional resources we need for the season, and present a proposal with a request to fund these from the Emergency Mosquito designation at the July Board meeting.
- **The District's Reserve Policy** was last approved in 2013, and needs updating, especially after some procedural changes we have implemented this year. I will review the policy and present proposed updates at a future meeting.
- **The District's updated Personnel Policy** will be presented at the July meeting for approval.
- **AUVSI FAA UAS Symposium** is an annual meeting of Federal Aviation Administration (FAA) staff to address Unmanned Aircraft Systems (UAS) regulatory integration, technical developments, and industry trends as well as work on future concepts for Advanced Air Mobility (AAM) which contemplates ways to ensure safe use of the national airspace in a future that includes widespread use of cargo and package delivery UAS as well as "air taxis". I have been invited by the FAA to participate in a panel discussion highlighting the use of UAS by mosquito control agencies and the work of the AMCA to help streamline regulatory compliance and increase safety.
- **General Manager Work Schedule**
I have sustained a non-work-related arm injury that requires surgery next week. I will work with Jake on the relevant HR processes. I intend to take some time off next week, then work from home until I am cleared to return to the office.
